B. RESOLUTION NO. 7 OF 2016----DCED LSA MONROE COUNTY GRANT FOR PFT RECREATIONAL PARK--PHASE III

1) DISCUSSION FROM THE BOARD OF SUPERVISORS and BIA

The township secretary, Susan Gibiser stated to the Board that Resolution pertains to the township submitting a grant to DCED Local Share Account - Monroe County Grant Program in the amount of \$441,420.00. The Funding Commitment Letter is being submitted along with the grant application and states the Township approved the resolution and the township is committing the amount of \$77,898.00 or 15% of the projected costs in cash funds towards the total of the projected cost of \$519,318.00 for Phase III of the PFT Park & Recreation. Gregg Pavlick stated to the BOS the projected cost of the project for Phase III will be for the bathroom facility, pavilions, septic, site work, utility & heat work, concession stand, picnic tables and miscellaneous structures. Contractors' costs are included in the total. If the township receives the grant in any amount, at that time, BIA will do a complete detailed project drawing and bid packet since the project will have to be done by sealed bids. Supervisor Fazio asked questions concerning the layout of the bathroom facility and concession stand. Gregg Pavlick stated the quote received from Oldcastle Precast is just a quote for pricing and a general layout of a typical facility to submit for the grant, it's not the exact facility that will be at the park. After receiving any funds from the grant, that's when the BOS can review plans that BIA will have drawn up in detail for the facility, pavilions, concession stand and any other buildings for the project. After Gregg talked about the procedure and Supervisor Fazio's concerns, she felt more comfortable about adopting the resolution and submitting for the grant.
