Executive session was held on11/9/21 to discuss potential litigation.

Roger Meckes, Supervisor, Pat Holland, Supervisor and Josiah Behrens, Tax Collector were sworn into office from Tom Nanovic.

A. PUBLIC COMMENTS: (3 Minute Limit)

Ned Ramm- Board of Director BCLStormwater Mgmt. -we have a problem with Storm water runoff as you probably already know. Ken Levit and Tom Larney have been working on this project for the last 3 years. Why we are here BCL is part of the waterway and there is risk of derogation because of the climate change, rail fall, storm run off the water come down off the roads down into BCL. It runs across a number of properties across BCL and sewage systems and picks up contaminates. Ultimately in ends up in the lake. The sentiment builds up and we loose of flood water storage we lose volume. This results in decrease value of the lake and property values. In 2019 we hired an Engineering Company to come up with a plan. Estimate cost would be \$428,000 to get this project done. We are looking from the Township to help find funding with grants. We are looking for the Township to partner with us to help find funding. We are glad to have our Engineer come in and meet. Supervisor Lignore

stated what is causing the issue, what did we do? We have a lot of communities that have the same issue. Attorney Nanovic stated I represent BCL and they are not asking the township for money. Mr. Ramm stated we have run off come down 903 and from the park and Dollar General and it comes down to us in BCL. Tom Larney stated, we are in a Water Shed area we are looking for ways to diffuse the water from us. Anything that you could do to help out and slow up the work. Supervisor Lignore stated once we open that door is there enough grants out there. Supervisor Bartulovich stated the issue is coming down 903 and since none of that is Township owned how would the Township help you with a State problem. If you were going to do work to divert water it would have to be done on 903. No, all the work would be done on our property. But it's fundamentally the responsibility of whoever has the problem. Attorney Nanovic stated that the issue is that there are grants available and some of them you would need to have the Municipality involved. They would find the grants and the Municipality and would not cost the Township anything and there would be no liability for the township. Supervisor Bartulovich stated I'm not opposed to it, I just want to understand. Supervisor Lignore stated don't take this the wrong way but I think you're putting the carriage before the horse. If you would have come to us stating this are the grants that we found. Mr. Ramm stated, we wanted to come to you first to apply for it. Supervisor Lignore stated I have no issues, you find them and it's not going to cost a thing we'll join you. Supervisor Bartulovich stated definitely worth exploring.
