RESOLUTION NO. 2020-23

A RESOLUTION OF THE BOARD OF SUPERVISORS OF PENN FOREST TOWNSHIP, CARBON COUNTY, PENNSYLVANIA AUTHORIZING PENN FOREST TOWNSHIP TO PERMIT FOOD CONCESSIONAIRES AT THE PENN FOREST TOWNSHIP RECREATION PARK

WHEREAS, Penn Forest Township is a township of the second class located in Carbon County, Pennsylvania; and,

WHEREAS, Penn Forest Township owns, operates and maintains a recreation field known as the "Penn Forest Township Recreation Park"; and,

WHEREAS, pursuant to Section 3(6) of Penn Forest Township Ordinance No. 2015-3 ("Ordinance") entitled, " AN ORDINANCE OF PENN FOREST TOWNSHIP, CARBON COUNTY, PENNSYLVANIA DEFINING AND ESTABLISHING RULES AND REGULATIONS FOR THE USE OF RECREATION FIELDS AND RECREATION FACILITIES OWNED BY PENN FOREST TOWNSHIP; FIXING THE HOURS OF THEIR USE; PROHIBITING CERTAIN CONDUCT THEREIN; REQUIRING RESERVATIONS FOR SPECIFIC USES; AUTHORIZING ADDITIONAL REGULATIONS AND THE CLOSING OF THE RECREATION FIELDS UNDER CERTAIN CIRCUMSTANCES; AND DESIGNATING ENFORCEMENT OFFICERS; ESTABLISHING FEES FOR USE OF RECREATION FIELDS AND RECREATION FACILITIES; AND PRESCRIBING PENALTIES FOR VIOLATION" no person shall "set up any booth, table or stand for the sale of any article or service whatsoever within the limits of the recreation field without permission of the Board of Supervisors; distribute, sell, service or rent any services or commodity or solicit for any purpose without permission of the Board of Supervisors."; and,

WHEREAS, pursuant to Section 5 of the Ordinance, "The Board of Supervisors is authorized to establish additional rules and regulations, delete existing rules and regulations, or

otherwise change, amend or alter the rules and regulations by resolution duly adopted at a regular or special meeting of the Board of Supervisors."; and,

WHEREAS, the Board of Supervisors believes it would be in the best interest of Penn Forest Township to permit food concessionaires at the Penn Forest Township Recreation Park.

NOW THEREFORE, be it hereby resolved as follows:

- 1. Penn Forest Township may permit food concessionaires at the Penn Forest Township Recreation Park.
- 2. In order to obtain permission from Penn Forest Township for a food concession at the Penn Forest Township Recreation Park, concessionaires must make written application to the Township Secretary, pay a fee of \$30.00 per day, provide satisfactory proof of adequate liability and automobile insurance, and provide such other documentation or agreements as may be required by Penn Forest Township.
- 3. Whether or not permission is granted to a concessionaire, and the times that a concessionaire is permitted to sell food at the Penn Forest Township Recreation Park, shall be within the sole and absolute discretion of Penn Forest Township.
