Jim Mcelvany- questioned what we would be using the sign for and if we would be using the sign for advertising. The BOS discussed this would be used for events and reminders. The BOS are looking into what is best for the Township.

<u>Cleo Fogal</u>- discussed that it is not a good idea, and it would bleed over the lake in BCL and it cost a lot of money. They discussed having the sign located at the Municipal Building.

<u>Mike Collins</u>- discussed it is a big waste of money. It is difficult to read at 55mph and it's going to be impossible to read.

<u>**Pat Fosdick**</u>- discussed property values, the lighting and distraction with accidents on 903. Taxpayers should be allowed to vote on this item.

<u>Charlie Somedel</u>- discussed the cost, and to provide the Taxpayers relevant information to the residents. When this comes down to approval the cost should be put out. Provide background information to the residents and the history of other LED signs.

<u>Elaine Carnellen</u>- discussed that you cannot see the sign, and this doesn't belong here in the mountain, it's a city thing. Put a visitor sign up and people visiting are here today and gone tomorrow. We live here and we care about here. Put some lighting in the park not the sign.

<u>Alex Vitti</u>- discussed what is the plan to put on the sign job openings and closings, not advertising. Supervisors discussed the sign would be used for job opening and closings.

Talon Fogal- not a fan of the sign because of light pollution.

Paul Fogal- discussed property values. Supervisors are unclear.

<u>Tim Bucci</u>- expressed his concern about the sign being passed. He discussed the distraction on 903 and the no passing zones. There is no need for it, we have other avenues for communication.

<u>Sandy Benedick</u>-BCL discussed concern regarding the large influx from town and elsewhere for the fireworks display and the parking and parking on 903 when we ran out of parking. Supervisor Bartulovich discussed we are trying to look into obtaining more property from the School District for more parking.

Supervisor Bartulovich- expressed the cost being too high, the proposal was not accepted. We are putting it out to bid, if the cost is too high it will not be accepted. Discussion regarding billboards on 903.

Supervisor Holland- expressed his dislike for the sign.

Bob Leary-IML- expressed the idea of putting the sign at the Municipal Building. The sign at PFT#2 sign does not bother him.
