

RESOLUTION NO. 92-4

Whereas, on June 1, 1992, Penn Forest Township enacted an Ordinance entitled, "An Ordinance Regulating the Disposal of Solid Waste Within the Township of Penn Forest, County of Carbon and Commonwealth of Pennsylvania, Providing Definitions, Establishing General Requirements for a Permit Application, Permit Fees, Further Providing Requirements and Standards for Sanitation, Establishing Penalties and Law Enforcement Provisions, Providing for Severability of Provisions, and Establishing Effective Date."; and

Whereas, Section 5.04 provides that permit fees shall be set by Resolution duly adopted at any regular or special meeting of the Penn Forest Township Supervisors.

Now therefore, be it hereby resolved that the permit fees for the garbage collection year beginning August 1, 1992 and ending July 31, 1993, shall be as follows:

I. Types of Permits

A. Residential Waste Permit - Permits one household unit to dispose of no more than four bags (capacity of each bag must be less than 30 gallons) of residential waste at a depository per week.

B. Light Commercial Waste Permit - Upon application and approval by the Administrator, permits one business to dispose of no more than eight bags (capacity of each bag must be less than 30 gallons) of light commercial waste at a depository per week.

II. Fee for Residential Waste Permit.

A. Discount Period - If full payment is received on or

before July 31, 1992, the permit fee is \$65.00.

B. Base Period - If full payment is received after July 31, 1992, but on or before August 31, 1992, the permit fee is \$75.00.

C. Penalty Period - If full payment is not received on or before August 31, 1992, the permit fee is \$95.00.

III. Fee for Light Commercial Waste Permit.

A. Discount Period - If full payment is received on or before July 31, 1992, the permit fee is \$130.00.

B. Base Period - If full payment is received after July 31, 1992, but on or before August 31, 1992, the permit fee is \$150.00.

C. Penalty Period - If full payment is not received on or before August 31, 1992, the permit fee is \$190.00.

IV. Per Bag Fee (Section 5.04 (c) of Ordinance No. 92 - 1)

A. Residential Waste

1. Persons without residential waste permits shall pay \$1.00 per bag (capacity of less than 30 gallons) to dispose of residential waste at a depository.

2. Persons with residential waste permits who want to dispose of more than the permitted four bags per week, shall pay \$1.00 for each additional bag (capacity of less than 30 gallons) of residential waste.

B. Light Commercial Waste - Persons with light commercial waste permits who want to dispose of more than the permitted eight bags per week, shall pay \$1.00 for each additional bag

(capacity of less than 30 gallons) of light commercial waste.

V. Renters Permit.

The person to whom a residential waste permit is issued for a household unit may obtain a renters permit for said household unit upon payment of \$5.00. The renter, upon displaying the permit to the attendant at a depository, shall have the same rights and obligations as the person to whom the residential waste permit was issued. This permit does not increase the limit of four bags of residential waste per household unit.

VI. Interest on Late Payment.

If the permit fees set forth in sections II and III are not paid on or before August 31, 1992, interest at the rate of 1 1/2% per month shall be added to the penalty period fee.
